## Juried Exhibition

PhotoZone Gallery's Annual Juried Show Exhibition provides a venue for fine art photographers from across Oregon to display their work. For some of the entrants, this exhibition is a chance to show work publicly for the first time.

All work submitted for exhibition each year is reviewed by members of the gallery. Graphic design, light and color, tonality, image power, originality and technical quality of each piece are considered.

This year out of a total of 83 photographs submitted, 48 were accepted, representing 24 photographers.

## PhotoZone Gallery

PhotoZone Gallery was founded in 1988 as a collective dedicated to the study, production, display, and promotion of fine art photography. Each year since then, the group has exhibited the work of its members and of invited guests, and has provided the community with a forum for the appreciation of photographic art. Over the past 22 years, the Gallery has shown the work of over 850 photographers. The group has not had a regular gallery for over seven years, but has had many group shows in various locations. This is the seventh year the Juried Show has been shown at the Emerald Art Center.

Members share responsibility for administering the organization, managing exhibitions, and contributing expenses.
